ABSTRACT

There is solid proof of existence of scientific discussions in Quran. The existence of 756 verses which are related to science shows the importance of scientific interpretations. The need for scientific interpretations has increased even more in modern day.

In modern day, one hurdle in writing scientific interpretation is the lack of command of commentators of scientific interpretations on the principles of Quranic interpretation.

The existence of secular media is a great obstacle for Muslim commentators of scientific interpretations. Secular media is misguiding the world by raising different objection regarding Islamic values and Quran. They are particularly targeting the educated class of Muslims. They are doing this in a very clever manner. For example, they would say "no doubt Quran was a great book 1500 years ago when it was written but it is outdated now as it can't fulfill the needs of modern day". On other occasions they would say that Quran is not a book rather it is the collection of small speeches.

However, there are hurdles for the commentators of scientific interpretations. This study attempts to highlight those.

Against this backdrop, this study will consist of two sections. First section will describe the hurdles in scientific interpretations and will suggest their solution. Second section will document scientific predictions and responsibilities of commentators.

They are intended to create imbiguities regarding the teachings of Quran.Even though they are doing it very wisely, like they state:Quran was appeared 1500 years ago and was the best book of that times". But it(Quran) is not matching with the needs of present times. Also state that Quran is not a book but a collection of short sermons that is why lack of coherence exist.

By using the principles of nusekh and mansookh, they say Prophet(S.A.W)used to change the verses of Quran as experiments. Regarding compilation, opponents try to mislead the young minds that Prophet(S.A.W) could not compile Quran as a book in his life that's why there are differences in the texts of Quran, because Quran as a book was designed/compiled lately.

It is clear that such allegations are baseless and rubbish. It is our faith that Quran has the solution of all worlds problem. Quran is the ocean of interpretations and one can collect precious pearls as per one's capacity.

Unawareness of languages of scientific literature.

The ratio of internet users is very less in Arab world because of language barriers. On the other hand, a few attention is being paid on website development in Arabic language.

The digital gap is being built between Arabs and developed nations due to negligence of such a revolutionary mode of communication.

Highly educated and skilled workers are heading towards developed countries with pace.

Arab countries are bearing much of this loss due to this rapid sift of intellectual. Whole Arab peninsula is experiencing sever shortage of litrary and art development. Publication on science and technology are coming to an end. Where as, there are about one lac and more scientific editions as well as more than ten lac thesis are being published every year in the world.

These numbers and scientific efforts must be translated in Arabic by dint of its importance.¹

Absence of translated version.

In 2001, Arab countries couraged to translate the science, techonology and comtemporary studies work which was just 330 in numbers. On the other hand, Greek, the sick man of Europe, translated five times more books in the same time scale. Spain ,an ordinary member of European union, translated books in Spanish which are higher than the efforts of 1000 years of Arab world. All this happened in one year, 2001.²

Scientific scholars of Quran are brealling the ice of wisdom and encouraging the readers to understand that Quran offers Sirat-e-Mustaqeem by exploring the universe with wisdom and guidance. So that the evidences for its existence, Toheed and total control could be justified.

Without this the human intellect is incomplete like; Quran says,

And the evolution of human lost in darkness because the wonders of universe open on those who concentrate".

Unawareness of Muslim scholars about scientific discoveries.

Muslim scholars are seeking scientific discoveries to make such a world for humankind where honesty, co-operation and brotherhood may exist. There would be harmony between words by action.

Muslim scholars can gain their last position only with quest of knowledge, dedication and consistency.

It may also be noted that science and technology leads toward progress and prosperity. This backward adversity and blind age are not our fate, we still have a chance to get our position back by making ourselves better with divine invitation.

Lack of command on Islamic studies wile explaining the scientific trend.

Today the major misconception is found about scientific explanation that Islamic scholars think that scientific explanation means the enlargement of natural intellect.But the scientific school of thought presents a different opinion that these principles are the name of search of divine orders in the diverse dimension of Quran and Sunnah.

Scientific litrary explanation is essential for the solution of modern problem generated by secularism, religious ignorance, liberalism and atheology.

Absence of scientific literature in modern intellectual and social structures.

Instead of closing the door of scientific commentary in the modern era, the method of collective opinion should be developed to express a new opinion in modern issues, so that the possibilities of opinions are increased and it is possible to get a correct opinion. According to human requirements, mistakes have been made by commentators, so scientific interpretations should continue to evolve. The intellectual an social demands of the present age and the solution of modern problems should be solve through scientific interpretation literature so that the difficulties of modern problems are resolved.

The requirements of scientific interpretation and its sensitivity should be fulfilled so that the blasphemy can be kept away from the interpretation. There is a dire need to analyze the intellectuals of the modernists an the orientalists in a scientific interpretation, even if Bayan Al-Quran, Taheeh Al-Quran, Ma'rif Al-Quran. There is a content in Tafsir Majdi, but this topic is very important so there is an urgent need to pay more attention to it.

Ignoring the guiding principles of scientific interpretation.

There should be no argument, which are secondary, there are no clear guidelines on such topics, it needs attention.

It is one of the responsibilities of the interpreters of the scientific commentary that the scientific commentary should be cocise, concise and reliable only. In important national and international issues, the aspect of maximum realism among commentators scholars are topics on which guidance should be provide in interpretations.

Lack of familiarity with the rules and regulations of acceptance of scientific interpretation.

through the literature of scientific interpretation, there is a need for greater intellectual harmony among Muslim commentators in the conflic between Islamic an non-Islamic ideas. Scientific interpretations should be written within the scope of tafsir, because the commentators have declared its scope to be based on the Quran and hadith, while its scope is wide, which has been mentioned in detail in this paper.³

The lack of reliability and detail in scientific interpretation.

Many things unrelated to scientific interpretation have been included in the interpretation, examples of which can be seen in tafsir Jawahir Al-Quran an tafsir Mufatih Al-Gheeb. And because of these aspects the credibility of the scientific interpretation was undermined and some commentators severely criticized the scientific interpretation of the Quran.

In this regard, Muhammad Ansar Javed writes that:

"one form of scientific interpretation is Tafsir Jawaher Al-Quran(Allama Johor Tontawi). So much scientific information and traditions have been collected in these tafsir that the quran is not a book of guidance." Come, rather these appear to be mental exercises of the commentators but there is a clear evolution."⁴

However, the thesis in this too, a small effort has been made. Scientific discoveries and the responsibilities of the interpreters.

That although the Quran is not a book of science, it is a source of other scientific sciences. All the new inventions and discoveries that have been made in the coming times have been mentioned in the book of Al Aziz explicitly and sometimes with hints.

This letter is also present in human beings to make new discoveries by conducting scientific research.⁵

In this regard, Dr. Sultan Bashir Mamood says:

"All scientific discoveries are first looked in our nature(Gene) and they are a sign of pre-existing knowledge".⁶

In addition, there are countless things that are dead or have been told to us by scientific research and analysis of or have been told through divine revelation. these are divided into three types of animals, plants and inanimate objects.

Adoption of Qu'ranic Preaching Style by Scientific Commentators

The writers opinion is that in order to end this difference, a council should be formed consisting of representatives to scholars from each school of thought and to review the work of interpretation in a modern way.

The Holy Quran has stated with full responsibility that the Holy Quran has also adopted a method of bringing the people of the whole world to the right path, which is to meditate on the universe twice.
